Twenty-two Grade 10 students and their teachers from schools in Ross River and Watson Lake came to site to learn about working in the mining industry.

The goal of the day was to share information about different jobs in mining and exploration. We also talked about the education and experience people need for these jobs.

AUGUST: TWO GROUPS OF ELDERS COME FOR A VISIT

We welcomed two groups of Elders from the Ross River Dena Council and Liard First Nation to the Selwyn Project in August. The weather was good, so we took helicopter tours and camp tours.

We flew the Elders around the Selwyn Project property, visited our Anniv drill site and toured the facilities in Don Camp, including:

- · the offices and medic and ambulance facilities
- the recreation room, the 'dry' (wash, shower and laundry) and the sleeping quarters
- the kitchen and dining facilities, where we shared a meal together
- the core shacks, where we saw how the drill core arrives at camp, by truck and helicopter, and how we log, mark and photograph the core









The Elders were interested to hear about what Selwyn Chihong is doing to protect water and wildlife at the proposed Project. They also gave us lots of good feedback. One of the highlights of the trip was when the Elders had the chance to meet up with some of the Kaska young people working at site.






2013 SPENDING IN YUKON

We are developing a training strategy to help local residents develop the skills they need for jobs in the mining industry. We estimate the proposed mine could create 1,500 jobs during construction and 750 jobs during operations.




About the Selwyn Project

The Selwyn Project is a proposed zinc-lead mine, located at Howard's Pass in eastern Yukon, 165 kilometres east of Ross River and 280 km north of Watson Lake, straddling the border with the Northwest Territories. The project is one of the largest undeveloped zinc-lead deposits in the world.

The Selwyn Project is in the advanced exploration phase. This means Selwyn Chihong, with its team of experts and consultants, is conducting the technical and environmental research and studies required to design the proposed mine and begin preparing to apply for the project to enter the environmental and socio-economic assessment process.

The Selwyn Project is owned and operated by Selwyn Chihong Mining Ltd., (Selwyn Chihong), the Canadian subsidiary of Yunnan Chihong Zinc & Germanium Co., Ltd.
