ABOUT THE SELWYN PROJECT


The Selwyn Project is a proposed zinc-lead mine, located in Howard's Pass in eastern Yukon, 165 km east of Ross River and 280 km north of Watson Lake, on the border with the Northwest Territories. The project is one of the largest undeveloped zinc-lead deposits in the world.



PROPOSED SELWYN PROJECT HIGHLIGHTS

- An open-pit mine with an estimated mine life of 11+ years (Phase 1)
- Completing permits for additional phase 2 drill program with another 10 years of mine life
- Processing capacity of 35,000 tonnes per day using conventional milling and flotation
- Estimated daily yield of 2,500 tonnes of wet zinc concentrate and 600 tonnes of wet lead concentrate, that will be trucked to the Port of Stewart for export
- Preliminary cost estimates - Capital cost: ~US\$ 2.12B
